If you can't attend, send in your vote by proxy!

Unable to attend the 2018 CMA National Conference in Vancouver? No problem! Make your vote count by giving your proxy to someone else.

First, you must be a voting member of CMA. We will check your status when you send in this form, so don't worry about the details. However, you **MUST** send it to us by either mail or fax before **March 28, 2018** so all the proceedings are legit. If you miss this deadline, your proxy voter may present this form to the CMA Executive Director **NO LATER** than noon on Tuesday, April 9, 2018.
